CENTER STATE CONFERENCE GIRLS AND BOYS TRACK AND FIELD BY-LAWS

- 1. Starting date will be the same as for all spring sports, established by the section/state.
- 2. Both boys and girls follow the federation rules.
- 3. League broken into Division 1, 2, and 3.
- 4. There will be two chairpersons in each division (one for boys and one for girls). All will be approved by the coaches at their post-season meeting and by the athletic directors.

DUTIES OF CHAIRPERSONS

- 1. Keep CSC meet and conference records.
- One boys and one girls chairperson from each division will represent CSC at section T/F meetings and will be responsible to relay the information back to the coaches within the division.
- 3. Should attend pre-season and post-season meeting for reps.
- 4. One chairperson will be responsible for ordering all meet ribbons.
- 5. Will be responsible for the CSC division meet including reporting results to the Observer Dispatch.
- 6. Will be responsible for the CSC Invitational meet, if held.
- 7. Each division chairperson will compile an all-star list and an end-of season report for all coaches and athletic directors.
- 8. Send information and manage league meet.
- Divisional championship meets will be the week prior to the class sectionals. A non-scoring all division meet may be held the weekend before class sectionals. Limited entries.

MEETS

- 1. Start at 4:30 p.m. weekdays.
- 2. Division one will compete in dual meets against each other.
- 3. Schools in each division will compete against each other at least once in a dual, double dual, tri or quad meet with dual meet scoring optional. Each division will determine points awarded for dual competition and/or CSC championship meet.
- 4. See enclosed order of events.
- 5. Each division will have a championship meet with points awarded to determine the six CSC team champions. Ribbons will be awarded 1-6 per event. School limited to three entries per event, one relay team. Scoring 10-8-6-4-2-1. Each school pays for one official, two additional officials per meet and ribbons will be paid for by CSC. Each school must provide two competent adult volunteer officials to time, etc.

- 6. To compete in the CSC championship meets, athletes must have competed in at least three league competitions during the season. To petition an athlete who has been injured and does not have three competitions, the athlete's coach must send a written petition letter to the AD representative by the Friday before the League Meet. A response will be returned to coach by the day prior to the league meet. No exceptions!
- 7. Spikes must be allowed at all league and divisional championship meets.
- 8. For divisional championship meets no event will begin after 10 p.m. Suspended divisional championship meets will be picked up the next day.
- 9. The conference may sponsor a CSC Invitational for T/F athletes from our conference, only. Three entries 1 relay no team scoring.
- 10. Visiting school must bring competent official to each meet.
- 11. Home school scores meet and sends results to newspaper (Observer Dispatch) same day.
- 12. Report results of all league meets to league chairs Tim @ Old Forge and Chad @ West Canada within 48 hours so they can be posted on the league website. www.csctrack.com.

SECTIONALS

- 1. Athletes must achieve the qualifying time/height/distance for each event established by the Sectional Committee for all classes.
- 2. Second set of qualifying time/height/distance must be met to go to open qualifying meet.
- 3. Entry forms for sectionals must be sent in by participating schools, (usually by May 1st) to the meet director.

RECORDS

- 1. The chairperson's will establish two sets of records for track and field athletes. These shall consist of championship meet records and conference records.
- 2. Times and distances recorded by CSC athletes in meets other than the championship meet may count as a conference record under the following conditions:
 - a. The record was achieved in a bonafide meet consisting of five schools or more.
 - b. All record performances be submitted to the designated chairperson with in two weeks of the date of the performance and include the following information:
 - 1. Name, place and date of meet
 - 2. Name of the meet director
 - 3. Athlete's name and school
 - 4. Time and distance/height

POST SEASON MEETING

1. The annual all-star meeting will be held on the Tuesday following the class meets each year.

ALL-STAR SELECTION

- 1. Thirty different athletes allowed for each division
- 2. At least two for each individual event (the event winner is an automatic choice). All all-stars will be selected at the post-season meeting by the coaches.
- 3. Forty -five "honorable mention" choices per division.
- 4. There will be a MVP Track and MVP field award voted on and given at each divisional meet.
