 Players are expected to dress in Golf Attire.
 No caddies or electric carts will be allowed unless necessary as per a specific disability.

ANCILLARY NOTATIONS:

- ➤ ATHLETIC EMERGENCY PROCEDURES: Each school participating will provide for the care and treatment of their athletes as per each school's policy in effect during the spring 2021 season.
- ➤ The Spectators Viewing Area will be on the Putting Green overseeing the 1st Tee Box and 18th Putting Green. All Spectators MUST stay in this area.
- NO spectators are permitted to walk and follow the players. This is a NJSIAA and Shore Conference Tournament Rule.
- ➤ In the event of a 1st Place Tie for the Individual Champion, a Playoff will commence on Hole #1. The winner will be determined by lowest score on the hole. (The playoff will move on to hole #2, etc. until the tie is broken and a champion is decided).

Tie Breaker for ALL INDIVIDUAL TIES for 2nd - 5th Place 1. (Sum of holes 10-18) 2. (Sum of Holes 13-18) 3. (Sum of Holes 16-18) 4. (18th hole score)

- A Team Tie will be broken by the 5th Player's score. Without a 5th Player, the team will default to the opposing team with the 5th Player. In the event that both 5th Player's scores are tied, the second tiebreaker will be the Lowest Individual Score will determine the Team Champion.
